Article 1. To choose a moderator to preside at said meeting.

Article 2. To see if the town shall vote to approve the Community Development Block Grant application(s) for the following program(s) and dollar amounts:

Program 1: Public Service Grant Amount: \$50,000.00

Program 2: Community Planning Grant Amount: \$10,000.00

and to submit same to the Department of Economic and Community Development and if said program is approved, to authorize the municipal officials to accept said grant funds, to make such assurances, assume such responsibilities and exercise such authority as are necessary and reasonable to implement such programs.
